1. PURCHASE AND DELIVERY PROCEDURE:

- i) Payment can be made through Credit Card, PayPal, Direct Bank Transfer, FPS, Alipay HK, PayMe.
- ii) If you choose to make payment through Direct Bank Transfer, FPS, Alipay HK, PayMe:
 - Please make payment within 24 hours after the order is confirmed.
 - Send us Proof of Payment through WhatsApp (6087-3331).
 - We will confirm with you once the payment is received.
- iii) Upon receipt of payment, the order will be scheduled for production. Under normal circumstances, the product will be dispatched within 1 week after payment is confirmed.
- iv) All orders will be shipped to addresses in Hong Kong. A delivery fee of \$30 will be charged per order. The delivery fee will be waived for net purchases of HK\$800 or above for each order. The aforementioned charges and free delivery are applicable only to domestic standard express services provided by SF Express. We may not be able to accommodate other delivery requests, and additional charges may apply.
